Sicily by Car S.p.A and IPA - International Police Association Sezione Italiana through the XXI Delegazione Venezia Giulia have entered into a discount agreement to be transferred to their members, formulas for the purchase of services and products through a specific agreement as in the present case in the car rental sector; according to the following terms and conditions.

DESCRIPTION OF SERVICE Sicily by Car, undertakes to reserve to all subjects referable to IPA - International Police Association a reserved discount equal to 15% calculated on the rental cost net of VAT and any additional supplements. The discount will be valid for daily rentals throughout Italy, of both electric and endothermic vehicles and vans. This discount cannot be combined with other current promotions and will be applied to the rate in force at the time of booking.

The discount is not combinable with other active promotions and is not applicable to fixed rates, monthly, multi-monthly, corporate, conventions and anything not expressly included in the base rental rate. Sicily by Car also undertakes to reserve, for the duration of the agreement, the following:

- 10% discount on the cost of the Car Protection Plus clause
- 10% discount on the cost of the Super Gold Protection clause
- 10% discount on the cost of the PAI clause
- 10% discount on the cost of the Road Assistance Plus clause
- 10% discount on the cost of the second guide accessory
- 10% discount on the cost of the third-driver accessory
- 10% discount on the cost of the child seat accessory
- 10% discount on the cost of the child seat accessory
- 10% discount on the cost of the priority check-in accessory

Otherwise, it will be possible to enter the discount identification code 'CN88IPA025' in the appropriate section of the booking area of the website or the MySbC app. Once the rental details have been entered, it will be possible to view the quote net of the reserved discount and then proceed with the type of payment chosen:

1. direct payment upon collection of the car, at the rental desk;
2. prepaid online at the end of the booking. Regardless of the chosen method of payment (on-site or prepaid online), it is required that the user making the booking is in possession of a financial (non-electronic) credit card in his or her name, which must be presented when the rental agreement is concluded. Each applicant will also be provided with appropriate support (badge, badge, etc..), attesting to the 'Convention' with 'IPA - International Police Association' in the absence of which will be charged to the customer the difference between the official rate in force at the time of booking and the rate with discount applied. Sicily by Car in the absence of the appropriate support required at the time of collection of the vehicle, also reserves the right not to proceed with the issuance of the rental contract.
